#### **Bronx River Housing Development Program Office**

The Bronx River Housing Development Program Office provides eviction prevention, entitlement screenings and benefits assistance to the residents of the Bronx River Housing Development. Located in the Soundview section of the Bronx, the New York City Housing Authority-owned Bronx River Houses are home to more than 3,000 residents, many of whom are families with young children.



#### **Norwood Office**

Although the BronxWorks Norwood Office is a brand-new location, it builds on decades of service to the neighborhood. This walk-in office provides access to benefits, information and referrals to the local community.



#### 800 Barretto Street

800 Barretto Street, recently dedicated in memory of Ellen Rose Associates founder and property owner Max Blauner, is home to the BronxWorks Department of Adult Homeless Services. Our Homeless Outreach Team and The Living Room staff are both based here; the shared space allows for staff to respond to crises quickly and encourages collaboration between teams.

#### **Stratford Towers**

The BronxWorks office at Stratford Towers offers residents benefits screenings, eviction prevention assistance, community resource referrals and social service programs. Each of the 112 units at Stratford Towers houses one to four residents.



#### **Betances Cornerstone Community Center**

The BronxWorks Betances Cornerstone Community Center provides residents of the nearby New York City Housing Authority Developments with an array of services, including youth development, community activities, and after-school and summer camp programs. Located in the Mott Haven section of the Bronx, Betances is one of four Cornerstones operated by BronxWorks.



#### The BronxWorks Farm Stand at CMCC

The BronxWorks Farm Stand is located at the Carolyn McLaughlin Community Center (CMCC) at 1130 Grand Concourse every Thursday afternoon from April to November. Cooking demonstrations and healthy recipes are available throughout the afternoon, and locally sourced fruits and vegetables are offered to the community at an affordable price.



# From the **Leadership**

#### Dear BronxWorks Friends and Family,

Thank you for browsing through our 2017-2018 Report to the Community, which features some of our recent accomplishments and events while recognizing select new and long-standing partnerships. Founded as the Citizens Advice Bureau in 1972 as a walk-in office with two staff members, BronxWorks has a rich history of providing services to community members and addressing the borough's changing needs. Thanks to our invaluable relationships with board members, corporations, foundations and supporters, BronxWorks continues to grow each year.

Every day, we live our mission to feed, shelter, teach and support our neighbors. This year, BronxWorks served more than 50,000 community members with 39 locations and 900 staff members across the borough. In 2017, the BronxWorks Family Eviction Prevention Supplement (FEPS) program helped 1,218 families with 6,643 persons secure \$6.9 million in arrears payments, enabling them to remain permanently housed. BronxWorks helped 871 households obtain Supplemental Nutrition Assistance Program (SNAP) benefits.

In addition to our recent progress, the Report to the Community includes information about our recently updated Strategic Plan, which guides the agency as we continue to lift lives and build futures. As we move forward, I invite you to:

**Visit BronxWorks.** The Carolyn McLaughlin Community Center at 1130 Grand Concourse, our flagship location, is always bustling with children in after-school programs, participants swimming in the indoor pool, adults participating in ESOL classes and more.

**Consider volunteering.** Our senior-centers, for example, offer a variety of activities with many opportunities to serve aging adults.

**Attend one of our events.** During the BronxWorks Annual 5K Run/Walk, participants support our programs while racing to the finish line. Runners vote on which program will receive the proceeds from the 5K.



## National Council of Jewish Women New York and HIPPY 25th Anniversary

Home Instruction for Parents of Preschool Youngsters (HIPPY) is an evidence-based early childhood development and parent education program. Recently, BronxWorks celebrated our 25th anniversary of offering HIPPY. HIPPY provides parents the tools to be their child's first teacher and prepares children ages 3 to 5 years for success. BronxWorks HIPPY facilitators meet with parents in their homes to provide lessons on how to teach their children to read. Often, HIPPY parents are immigrants with limited English proficiency, and the curriculum strengthens their literacy skills as well.

Although there are more than 100 HIPPY sites nationwide, BronxWorks is the only provider in New York State. The National Council of Jewish Women New York (NCJW NY) introduced BronxWorks to HIPPY in 1992 and continues to support and advocate for the program. Thanks in large part to NCJW NY, the BronxWorks HIPPY program has enrolled more than 2,000 families since its inception.



### Willie Colon Foundation

Each year, Bronx native and retired New York Jets player Willie Colon returns with his family and several of his teammates to the BronxWorks Classic Community Center as part of the annual Willie's Turkeys and Toys Event. Willie continued the tradition this year, and residents of Melrose Houses, a New York City Housing Authority Development, enjoyed a hot breakfast and received turkeys to help celebrate Thanksgiving.

#### **Robin Hood Foundation**

The Robin Hood Foundation, the agency's largest private institutional funder, has supported BronxWorks since 1997. The foundation contributes to many of the agency's programs and services.

Robin Hood began funding the BronxWorks Single Stop program in 2003. A Robin Hood–affiliated entity, Single Stop USA was subsequently created and now serves as the funding conduit for BronxWorks walk-in offices, information and referral service program. Single Stop offers community members one place where they have access to financial, housing, benefits and family service help at no cost. From 2013 to 2018, Robin Hood contributed \$1.1 million to BronxWorks Single Stop operations. In 2018, the BronxWorks Single Stop and walk-in offices provided services to more than 4,000 individuals.

In addition to Single Stop, the Robin Hood Foundation funds programs for children and youth, including the Early Childhood Learning Centers. The Robin Hood Foundation has supported the BronxWorks Homebase program, which offers a variety of homelessness prevention services. Robin Hood also provided funds to the agency in the aftermath of Superstorm Sandy. In addition, Robin Hood introduced several BronxWorks board members to the agency.

Since 1999, Robin Hood contributed more than

\$12 million

to various BronxWorks programs.



# **New Partnerships**

BronxWorks is pleased to feature some of our recently formed alliances, which support our mission and help the agency launch exciting new initiatives for our program participants.

### Children's Hope India

Children's Hope India (CHI) first partnered with BronxWorks in 2016, when CHI helped the agency launch a media workshop for participants at the BronxWorks Cornerstone Community Centers. CHI continues to support BronxWorks children and youth programs with funding for Science, Technology, Engineering, Art and Math (STEAM) lessons at the Bronxchester and Third Avenue after-school programs. Thanks to CHI, students enjoy educational and hands-on experiments on topics including plant life, outer space and the nature of sound. The program culminates in a science fair, where students showcase their knowledge and hard work with exciting projects on a topic of their choosing.

Over the holidays, CH3, a group of teenage volunteers affiliated with CHI, generously surprised the students with gift bags filled with gloves, hats and other cold weather clothes.

The ASPCA also helps Bronx residents by bringing its mobile units to community events, where BronxWorks often has a presence.


